The Rehabilitation Services Administration (RSA) awarded Department for Aging and Rehabilitative Services (DARS) a 9.4 million dollar, 5-year demonstration grant. The grant's goal is to employ 750 individuals with disabilities in high wage, high demand careers in registered apprenticeships, government, and STEM/Healthcare. DARS and Division of Registered Apprenticeship (DRA) collaborated with

the intent to educate individuals with disabilities, businesses and community partners of the benefits of the Registered Apprenticeship Model. This session will highlight joint efforts of DARS and DOLI to collaborate across teams and develop best practices related to the growth of registered apprenticeship opportunities for Virginians with disabilities. Strategies in use include ride along visits to employers, Windmills disability etiquette training to employers, the creation of a self-referral form for new apprentices.

Founded in 2008, the Policy Group on Tradeswomen's Issues (PGTI), is a multi-stakeholder collaboration of over 75 construction industry stakeholders committed to crushing the barriers to women's access to good jobs in the union construction trades. Over the past 14 years, participating stakeholders have been engaged in developing, implementing and evaluating both a strategic framework and technical tools for

increasing participation of diverse workers in the pipeline from recruitment into apprenticeship through the steady employment that is a precondition to a successful career in the construction. This session will discuss PGTI's strategic framework, the Integrated Supply and Demand Model, which provides a conceptual approach to the variety of barriers faced by women and people of color entering the industry and also by those stakeholders who seek to change entrenched ways of doing business that reinforce the exclusion of diverse workers.

"Since 2017 the State University of New York (SUNY) has been supporting the expansion of Registered Apprenticeship in NYS. This is primarily done by offering funding to cover Related Instruction provided by SUNY schools for eligible programs. This work has led to a strong collaboration with the New York State Department of Labor (NYSDOL), including ensuring apprentices can receive training across the state, verifying sponsors/apprentices, conducting joint outreach and marketing and exploring opportunities for new trades. This session will begin with a description of SUNY's involvement in Registered Apprenticeship and then turn to an in-depth discussion about the collaboration between SUNY and NYSDOL.".

In August of this year, Departments of Labor and Education collaborated on joint strategies to address Teacher workforce challenges with three priorities: "(1) establish high quality paid Registered Apprenticeship programs for teaching; (2) increase collaboration across workforce and education systems, including strengthening career pathway partnerships, to bring more people into the education profession through high-quality pathways, such as providing opportunities for school-based staff to become teachers; and (3) ensure teachers are paid a livable and competitive wage. All of these efforts will help address labor shortage challenges made worse by the pandemic and benefit students and communities across the country."

The first strategy is to establish a Registered Apprenticeship Program for Teaching. Today you will hear from organizations who were early adopters of this strategy. Please join us to learn about the many partnerships, strategies, and on-going support and service systems available to you when you adopt an apprenticeship program for educators in your own community.
